# **SECTION 2. STANDARD PROCEDURES**

# 2. PART 1 - What we do:

We provide online marketplace platforms and social media marketing, using web-based technology that connects Merchants, Major Merchant Delivery Platform/s ("MDP"), Independent Contractors (contractor/s) and Retail Customers (customers). Onsiteclick's software and services permits customers to place orders for food and/or other products from Merchant on ASU and MDP's; Onsiteclick's software and MDP's then notifies MDP delivery contractors and platforms that a delivery opportunity is available; after an Onsiteclick platform and/or contractor communicates its acceptance of the delivery, then Onsiteclick's software and MDP's facilitate the completion of the delivery of the Merchant's products to the customer. Onsiteclick is not a merchant, food preparation business, reseller, or delivery service; we're an online connection, social media marketing and consulting company that assist Merchants in selling their products online.

#### 2. PART 2 - What you do.

You fulfill orders placed on the Onsiteclick LP "Assigned URL" Platform (See Section 1, Part 2) and/or any other MDP platforms setup on your behalf. You will provide orders to assigned delivery contractors, MDP platforms and/or customers. Instead of collecting payment at the time of pickup, you will maintain an account of the total sales for each order (including all taxes and governmental charges) in your record-keeping system, for all sales made on your behalf.

# 2. PART 3 - Payments & Pricing.

Onsiteclick LP payment to merchant will take place, from commission sales only, as follows:

Thursday of every week, Onsiteclick LP will settle your house account by paying you

- i. the pre-tax total of all orders for the prior week (Monday to Sunday), plus
- ii. the total sales tax on all such orders, less:
  - a. Sales Incentive Rate: 15% commission (excl. Taxes & Fees) per order
  - b. Assigned URL (ASU) Subscription: \$29.99/month
  - c. Third-Party Credit Card Processing Fees: 2.9% + 30¢ per successful card charge (Stripe charges)
  - d. OPTIONAL: Video Production, Social Media & Other Consulting: \$35/hour and/or \$15/hour for site maintenance, updates, and marketing campaigns, PLUS Cost of Advertising, when requested by Merchant
  - e. <u>FREE Weekly Staff Tip Payments</u>, ("staff tips administrator" assignment by merchant).
  - f. FREE MDP Setup & Contracting with all major delivery platforms available in the Merchant's area
  - g. FREE Merchant Staff Training for selling ASU platform in particular and MDP's in general
- iii. You are the "retailer" or "seller" responsible for remitting all sales tax and other governmental charges. You are also responsible for setting the price for each item to be made available on the Onsiteclick "Assigned URL". You must inform Onsiteclick LP writing if you set a price for items available on the Onsiteclick "Assigned URL" that exceeds the in-store price for the same items or the price for the same items as may be available through any other similar platform.
